1	Will the academic year 113 be implemented as 16+2- week or 16 weeks?	The 16+2-week is still implemented in the 113 academic year, but 16 weeks can only be implemented after receiving approval from the Ministry of Education in the 114 academic year.
2	Can teachers arrange schedules for +2 at will? (not limited to Weeks 17 and 18)	Weeks 17-18 will remain the same as the original times for week 17th and 18th in the 113 academic year. If there is a need to adjust or make up classes, please submit form for changing time or make up of missed lesson according to the school's regulations. If the 114 academic year successfully changes to 16 weeks, then the courses originally scheduled for Weeks 17-18 can be completed within the 16-week duration, without any additional restrictions. However, teachers still need to complete the hours for Weeks 17-18 within the semester.
3	What's the difference between the new 16-week system and the current 16+2-week system?	 1.In the current 16+2-week system, the flexible supplementary teaching time should be scheduled within Weeks 17 and 18. 2.Under the new 16-week system, it is advised that instructors complete the course within the 16-week duration, and any flexible supplementary teaching should end within Week 16. 3.The school will continue to evaluate the effectiveness of the 16+2-week implementation and make rolling adjustments accordingly.
4	The 16+2-week is implemented in the 113 academic year. Can students submit their final report or final assignment in the week 18 and have their grades assessed afterwards?	The deadline of grade submission remains the 19th week on Friday in the 113 academic year. There is no difference between the first and second semesters. However, if teacher finishes early, submissions can be made in advance.
5	When are the mid-term and final exams scheduled in the 113 academic year?	The midterm exam will be in the 8th week, and the final exam will be in the 16th week.
6	Will the implementation of a 16-week schedule affect the hourly paying for adjunct instructors?	No, the actual hourly pay will still be compensated for 18 weeks. This is because teachers still need to fulfill the requirement of teaching 18 hours for one credit, even though the course instruction is completed within 16 weeks as per the schedule.
7	If 16 weeks teaching is implemented, can the original flexible supplementary teaching time in weeks 17 -18 be accepted as long as the teachers and the students agree on the time?	Weeks 17-18, students do not attend school. From the perspective of promoting student autonomous learning, it is acceptable as long as the students agree with the teachers on the time. Furthermore, flexible supplementary teaching doesn't necessarily need to be conducted within the classroom. Teachers are encouraged to modify the course content and consider alternative arrangements such as: industry practice, inquiry and practice, project assignment, off-campus visits, various on-campus/off-campus talks or seminars, online assignments, digital self-learning, remote teaching (synchronous or asynchronous), student-led study, or any other forms of flexible supplementary teaching. All the above courses should be completed within 16 weeks.
